Vidya Prasarak Mandal's Thane Municipal Council Law College, Thane, has consistently endeavoured to fulfil the broader social mandate of legal education by integrating academic learning with community engagement. The institution firmly believes that law is not merely a professional discipline but a powerful instrument for social transformation. In a diverse and populous country like India, where a significant portion of citizens remain unaware of their legal rights and remedies, legal awareness assumes critical importance. Recognising this reality, the college has institutionalised legal aid and legal literacy activities as an essential component of its academic and social responsibilities.

The Legal Aid Cell of the college functions as a structured platform through which students and faculty collectively contribute to the dissemination of legal knowledge among the general public. The Cell seeks to bridge the gap between law and society by simplifying complex legal provisions and making them accessible to ordinary citizens. The institution's commitment to legal aid is

rooted in the constitutional philosophy of justice, equality, and dignity, which underpins the Indian legal system. Through sustained legal awareness programmes, the college aims to empower individuals, prevent exploitation, and promote lawful behaviour.

The activities undertaken by the Legal Aid Cell during the academic year 2024–2025 reflect a comprehensive approach towards legal literacy. Rather than limiting itself to isolated events, the Cell adopted a continuous and multi-dimensional strategy involving lectures, workshops, public rallies, competitions, and field-based awareness campaigns. These initiatives were carefully designed to address contemporary legal issues, social challenges, and statutory mandates, thereby ensuring relevance and effectiveness.

## **FUNCTIONING OF THE LEGAL AID CELL AND INFRASTRUCTURAL SUPPORT**

The Legal Aid Cell of Vidya Prasarak Mandal's Thane Municipal Council Law College functions from a dedicated office located within the college campus. This office serves as the central point for planning, coordination, execution, and documentation of all legal aid and legal awareness activities. The existence of a separate and identifiable Legal Aid Cell office enhances institutional accountability and provides students and members of the public with a reliable point of contact for legal awareness initiatives.

Since its establishment in the year 2012, the Legal Aid Cell has steadily evolved in its scope and functioning. Over the years, it has developed systematic procedures for organising programmes, maintaining records, and coordinating with external authorities such as the District Legal Services Authority, Thane. The Cell functions under the guidance of Mr. Vinod H. Wagh, In-Charge of the Legal Aid Cell, who ensures that all activities are conducted in accordance with legal and ethical standards. The Principal of the college, faculty members, and the management of Vidya Prasarak Mandal extend continuous academic and administrative support to the functioning of the Cell.

The infrastructural support provided to the Legal Aid Cell enables it to function efficiently throughout the academic year. The office is used for student orientation sessions, preparation of legal awareness materials, planning meetings, and maintenance of reports and photographic records. This structured functioning ensures continuity of activities and facilitates the preparation of comprehensive annual reports, which are essential for institutional review and statutory compliance.

## **ORIENTATION AND CAPACITY BUILDING OF STUDENTS**

At the commencement of the academic year 2024–2025, students from various years of the LL.B. programme were oriented regarding the objectives, scope, and significance of legal aid and legal awareness activities. This orientation programme was conducted with the specific intention of preparing students for responsible and ethical public interaction. Students were made aware that legal aid activities involve a high degree of sensitivity, particularly when dealing with vulnerable sections of society.

During the orientation, emphasis was laid on the distinction between providing legal awareness and offering legal advice. Students were clearly instructed that their role was limited to spreading awareness about legal rights, duties, and remedies in general terms, without giving personalised legal opinions or advice. This ethical boundary was reinforced to ensure compliance with professional standards and statutory requirements.

Capacity building of students was treated as a continuous process rather than a one-time activity. Faculty members provided guidance on communication skills, public engagement, and the use of simple language while explaining legal concepts. Students were encouraged to view legal aid not merely as an academic requirement but as a social responsibility that contributes to the realisation of justice. This preparatory phase ensured that all subsequent programmes were conducted in a disciplined, informed, and effective manner.

## **SPECIAL LECTURE ON CONTROL OF DRUG ABUSE AND ILLICIT TRAFFICKING**

In observance of the International Day Against Drug Abuse and Illicit Trafficking, the Legal Aid Cell organised a special lecture focusing on the legal, social, and health-related aspects of substance abuse. The programme was organised with the objective of creating awareness among students and the community regarding the harmful effects of drug abuse and the legal consequences associated with illicit trafficking of narcotic substances.

Judicial dignitaries associated with the District Legal Services Authority, Thane, addressed the gathering and highlighted the growing concern of substance abuse among youth. The speakers elaborated on the provisions of the Narcotic Drugs and Psychotropic Substances Act and emphasised the preventive, punitive, and rehabilitative dimensions of the law. The role of educational institutions in identifying early signs of substance abuse and promoting awareness was also discussed in detail.

The programme was organised in conjunction with the celebration of the birth anniversary of Rajarshi Shahu Maharaj, a social reformer who championed

equality and social justice. This contextual linkage reinforced the values of social responsibility and public welfare. The lecture succeeded in sensitising participants to the seriousness of the issue and encouraged students to actively participate in awareness initiatives aimed at prevention and rehabilitation.

## **AWARENESS PROGRAMME ON THE PROTECTION OF CHILDREN FROM SEXUAL OFFENCES ACT, 2012**

Child protection constitutes a critical area of legal and social concern. Recognising this, the Legal Aid Cell organised a dedicated awareness and sensitisation programme on the Protection of Children from Sexual Offences Act, 2012. The programme aimed to educate teachers, non-teaching staff, and representatives of educational institutions about the statutory framework governing offences against children.

The resource person, a practising advocate, provided a comprehensive overview of the Act, including the definition of offences, reporting mechanisms, and the responsibilities of institutions. Special emphasis was placed on the importance of mandatory reporting and the consequences of non-compliance. The concept of child-friendly procedures was explained to ensure that institutions adopt sensitive and appropriate approaches while dealing with such cases.

The programme contributed significantly to enhancing institutional awareness regarding child safety and legal compliance. Participants gained clarity on their roles and responsibilities under the law, thereby strengthening preventive mechanisms within educational environments.

## **CONSTITUTION AWARENESS CAMPAIGN AND STATE-LEVEL ELOCUTION COMPETITION**

As part of the commemoration of seventy-five years of the Indian Constitution, the Legal Aid Cell undertook a comprehensive Constitution Awareness Campaign. The campaign sought to promote constitutional literacy and reinforce democratic values among students and the wider community.

A State-Level Online Elocution Competition on the theme “My Constitution – My Duties” was organised as a key component of the campaign. The competition witnessed participation from students across Maharashtra and provided a platform for thoughtful engagement with constitutional principles. Participants articulated their understanding of fundamental duties,

democratic responsibility, and the relevance of the Constitution in contemporary society.

The competition not only encouraged intellectual reflection but also fostered respect for constitutional governance. It served as an effective medium to engage youth in meaningful dialogue about their role as responsible citizens in a constitutional democracy.

## **CONSTITUTION DAY RALLY AND PUBLIC ENGAGEMENT INITIATIVES**

On the occasion of Constitution Day, the Legal Aid Cell organised a Constitution Awareness Rally with prior permission from the local police authorities. The rally was conducted in prominent public areas of Thane city and witnessed active participation from students and faculty members.

Through banners, slogans, and disciplined conduct, the rally conveyed the importance of the Constitution, rule of law, and democratic values to the general public. The rally served as a visible and impactful means of spreading constitutional awareness beyond the confines of the campus.

In addition, an innovative initiative titled “Selfie with the Constitution” was implemented to encourage creative public engagement. This initiative attracted spontaneous participation and enhanced the outreach and visibility of the awareness campaign, particularly among youth.

## **WORKSHOP ON CONSUMER DISPUTES AND MOTOR ACCIDENT CLAIMS**

The Legal Aid Cell organised a one-day workshop on “Consumer Dispute and Motor Accident Claims: Law, Procedure and Practice” with the objective of enhancing practical legal knowledge among students. Judicial officers and legal practitioners delivered detailed sessions on consumer protection laws, procedural aspects of consumer disputes, and the functioning of consumer forums.

The workshop also addressed legal issues relating to motor accident claims, including compensation mechanisms, insurance procedures, and road safety regulations. The interaction between students and experts provided valuable insights into real-world legal practice and dispute resolution mechanisms.

## **WORKSHOP ON SKILLS IN JUDICIAL PROCESS AND LEGAL PROFESSION**

A half-day workshop on “Skills in Judicial Process and the Legal Profession” was organised towards the end of the academic year. Former District Judges shared their professional experiences and provided guidance on judicial conduct, ethics, and career opportunities in the legal field.

The workshop emphasised the importance of integrity, discipline, and responsibility in legal practice. Students benefited from practical advice and gained a deeper understanding of the professional expectations associated with the legal profession.

## **COMMUNITY-BASED LEGAL AWARENESS AND HANDBILL DISTRIBUTION PROGRAMME**

In addition to institutional programmes, the Legal Aid Cell conducted extensive community-based legal awareness activities. A total of forty-five students participated under faculty supervision. Thirty students were actively involved in the preparation and distribution of approximately one thousand legal awareness handbills, while the remaining students handled coordination, documentation, and logistics.

The handbills covered topics such as anti-ragging laws, the Right to Information Act, the Right to Education Act, the Protection of Children from Sexual Offences Act, consumer protection laws, cyber laws, and fundamental rights and duties. Students interacted with members of the public and explained legal provisions in simple language, ensuring ethical and responsible engagement.

## **IMPACT AND OUTCOME OF THE LEGAL AWARENESS ACTIVITIES**

The legal awareness activities generated positive responses from the public. Citizens appreciated the efforts of the institution and expressed interest in understanding laws relevant to their daily lives. The programmes enhanced legal literacy and encouraged lawful conduct.

For students, the activities provided practical exposure, improved communication skills, and fostered a sense of social responsibility. The initiatives contributed to holistic legal education by combining academic learning with community service.

The Legal Awareness Campaign conducted during the academic year 2024–2025 under the supervision of the Legal Aid Cell of Vidya Prasarak Mandal’s

Thane Municipal Council Law College, Thane, was a structured, decentralised, and student-driven initiative aimed at spreading legal literacy among the general public. The campaign was implemented over a sustained period, particularly during September and October 2024, ensuring continuity, effective outreach, and meaningful engagement with diverse sections of society. Rather than being confined to a single event or location, the programme was designed as an extended field-based activity to maximise public interaction and impact.

The campaign primarily comprised the distribution of legal awareness handbills and the delivery of legal awareness lectures and interactive sessions at various public and semi-public locations. These activities were undertaken by law students either individually or in small groups under faculty supervision, thereby facilitating direct engagement with the community at the grassroots level. This approach enabled students to communicate legal concepts in a personalised and accessible manner while addressing the immediate informational needs of citizens.

Handbill distribution formed an important component of the campaign and was carried out across several residential localities, public spaces, institutional premises, and neighbourhoods in and around Thane city. Areas such as Brahmand (Thane West), the Ghodbunder Road vicinity, residential societies, public gathering points, and educational and institutional surroundings were effectively covered. The handbills were prepared with due care to ensure clarity, accuracy, and simplicity of language, enabling members of the public to retain and refer to the information at a later stage. This method proved to be an effective tool for extending legal awareness beyond verbal interaction.

Alongside handbill distribution, students also conducted short legal awareness lectures and interactive sessions at various venues, including educational institutions, workplaces, community spaces, and informal public settings. These sessions were deliberately kept brief, focused, and interactive to suit the attention span and availability of the audience. Students explained legal concepts in simple and comprehensible terms and responded to basic queries raised by the participants, while strictly adhering to ethical guidelines by avoiding the provision of individual legal advice.

The campaign covered a wide range of legal topics that are directly relevant to everyday life and social welfare. Awareness was created on the rights of senior citizens, particularly with regard to maintenance and legal protections available to elderly persons. Anti-ragging laws were explained with emphasis on the prohibition of ragging, its harmful consequences, and the legal mechanisms available for prevention and redressal. Consumer protection

laws were discussed to educate citizens about remedies available in cases of defective goods or deficient services and the role of consumer forums.

Significant emphasis was also placed on cyber laws and cyber safety, especially in the context of increasing instances of online fraud and misuse of digital platforms. Students highlighted the importance of responsible digital behaviour and basic precautions to prevent cybercrime. Awareness regarding fundamental rights and fundamental duties was imparted to reinforce constitutional values and the balance between individual freedoms and social responsibilities.

In addition, the campaign included awareness on alternative dispute resolution mechanisms such as arbitration and conciliation. By introducing these concepts, students familiarised the public with non-litigious methods of dispute resolution, thereby promoting amicable settlement of disputes and reducing the burden on courts. Certain awareness sessions were tailored to specific audiences such as bank staff, young adults, students, and working professionals, reflecting a context-sensitive and audience-oriented approach rather than a uniform or generic model.

The response from the public to the Legal Awareness Campaign was positive and encouraging. Citizens actively participated in discussions, raised queries, and expressed appreciation for the efforts taken by law students to simplify and explain legal provisions. The interactions helped demystify law and strengthened public confidence in legal institutions and processes.

From the students' perspective, the campaign proved to be an invaluable learning experience. It enhanced their understanding of the practical relevance of law, improved their communication and interpersonal skills, and sensitised them to the real-life legal concerns faced by ordinary citizens. The programme also fostered a sense of social responsibility and reinforced the ethical dimensions of legal practice.

Importantly, the Legal Aid Cell ensured that the campaign was conducted in a non-duplicative and well-coordinated manner. Students were encouraged to engage with different locations, audiences, and legal themes within the broader framework of the campaign. While certain key legal topics naturally recurred due to their importance, each activity remained distinct in terms of location, audience, and mode of interaction. This approach ensured wider coverage and avoided mechanical repetition of activities.

Overall, the Legal Awareness Campaign conducted during the academic year 2024–2025 was systematic, participatory, and impact-oriented. Through effective mobilisation of students, decentralised implementation, and meaningful public engagement, the programme substantially advanced the objectives of the Legal Services Authorities Act, 1987. The campaign contributed to the promotion of legal literacy, access to justice, and social empowerment, thereby reaffirming the institution’s commitment to community-oriented legal education and constitutional values.

## CONCLUSION

The Legal Aid Cell of Vidya Prasarak Mandal’s Thane Municipal Council Law College, Thane, successfully conducted comprehensive legal awareness and legal literacy activities during the academic year 2024–2025. The programmes were organised systematically, avoiding unnecessary duplication while ensuring thematic continuity. Through sustained efforts, the institution contributed meaningfully to the objectives of the Legal Services Authorities Act, 1987, and reaffirmed its commitment to access to justice, legal empowerment, and constitutional values.



## Special Moot Court Lecture for First-Year Law Students

On 24th October 2024 at 7:00 PM, a special lecture on Moot Court activities was organized for first-year law students by Assistant Prof. Yatin Pandit and Assistant Prof. Chandani Ghogre. The session aimed to introduce students to the basics of court-related exercises (moot court activities), which play a significant role in legal education.

This interactive session covered the following key topics necessary for understanding and participating effectively in moot court exercises:

The lecture introduced students to the concept of a moot court, a simulated courtroom proceeding where students argue hypothetical legal cases. Unlike real trials, moot courts focus on legal arguments rather than disputed facts. The speakers emphasized the importance of moot courts in developing legal research and advocacy skills, giving students a clear understanding of their structure and objectives. The importance of moot court was highlighted as a practical tool that bridges theoretical knowledge and real-world application. Participation in moot court enhances a student's abilities in legal research, writing, and oral advocacy. It also boosts confidence and the ability to think critically under pressure, helping prepare students for future legal careers. A major focus of the session was on the process of preparing a memorial, or a written submission. Students were guided on how to construct their memorials, including:

- Drafting the statement of facts
- Framing issues
- Presenting arguments
- Referencing legal authorities
- Drafting the prayer clause

Emphasis was placed on clarity, coherence, formatting, and the significance of comprehensive legal research. The final part of the session addressed techniques for delivering oral arguments effectively. Students were taught strategies for:

- Structuring arguments logically
- Responding to judges' questions
- Maintaining composure and professionalism

Practical tips were shared on voice modulation, eye contact, and body language to enhance persuasive communication during oral submissions.

In light of this and as part of practical training, a special offline lecture on "Accountancy for Lawyers" was organized by the college on Saturday, 26th October 2024, from 5:00 PM to 7:00 PM. ## Justice Delivery System in India on the Criminal Side – Sir Lallubhai Shah Memorial Lecture

On 23rd December, a delegation of 35 students from VPM's TMC Law College, Thane, accompanied by Prof. Hetal Meshrie and Prof. Krishna Kamath, attended the special lecture organized by the Department of Law, University of Mumbai, on the topic "Justice Delivery System in India on the Criminal Side". The keynote address was delivered by Hon'ble Justice Abhay S. Oka, Judge, Supreme Court of India, renowned for his deep legal acumen, unwavering commitment to justice, and consistent efforts in law enforcement. Justice Oka offered a comprehensive and insightful perspective based on his rich judicial experience and scholarly background. During his address, he urged law students to pursue litigation practice after earning their LL.B. degrees, emphasizing the critical need for young professionals in the judicial process. Highlighting the backlog of pending cases in courts, he stressed the importance of expeditious adjudication. Justice Oka proudly stated that India possesses one of the fairest criminal justice systems in the world, free from discrimination of any kind. He illustrated this point by referring to the Kasab trial, emphasizing the principle of fair hearing, even in the most sensitive and high-profile cases. He briefly explained the functioning of India's criminal jurisprudence and shed light on the rights of the accused under Indian law, underscoring the constitutional guarantees of justice and due process. The session concluded with an interactive Q&A, during which Justice Oka patiently answered questions from aspiring young law students, providing practical insights and encouragement. The session was educational, inspiring, and thought-provoking, offering students a rare opportunity to engage with one of India's most respected judicial minds.

## Lecture on Investment in the Share Market

On 17th February 2025, *Vidya Prasarak Mandal's TMC Law College* organized a special lecture on the topic of Share Market. The session was conducted by investment advisor Mr. Omkar Parab. He explained that a share represents ownership in a company, giving shareholders a claim on the company's assets and profits. He elaborated that the stock exchange is a platform where buying and selling of shares takes place. Mr. Parab introduced the concepts of Bull Market (indicating a rising market) and Bear Market (indicating a falling market). He also explained IPO (Initial Public Offering) as the process by which a company offers its shares to the public for the first time. Another key point covered was dividends, defined as a portion of a company's profit distributed to its shareholders. The lecture proved to be informative and engaging for both students and faculty members, offering valuable insights into the fundamentals of investing in the stock market.

## “Law & Medicine- the Connect and Interplay”

### One-Day National Seminar on “Law & Medicine- the Connect and Interplay” Organized at VPM’s TMC Law College

On 22nd February 2025, a one-day national seminar on the theme “Law & Medicine- the Connect and Interplay” was organized at VPM’s TMC Law College, Thane. The seminar was divided into a total of six sessions. The inaugural session was graced by the presence of the institution's President Dr. Vijay Bedekar, Hon’ble S.P. Tawde, Chairman of Maharashtra State Consumer Disputes Redressal Commission, Dr. Shivkumar Utture, Member, National Medical Commission, and Dr. Madhuri Pejaver, Former Dean of Mumbai University. Dr. Srividhya Jayakumar welcomed all the guests and introduced the theme and importance of the seminar. In this session, representing the institution, Dr. Madhuri Pejaver elaborated on the historical background and legal aspects of medico-legal issues. She also suggested the inclusion of laws related to animal welfare during drug trials.

Justice S.P. Tawde, in his inaugural address, spoke about consumer rights in cases of medical negligence and referred to some landmark judgments of the Supreme Court of India, highlighting the available legal remedies. He also emphasized that during accidents, patients and their relatives should act honestly and in accordance with the law, and that doctors should not fear legal action if they are not at fault.

Dr. Shivkumar Utture gave a detailed explanation of the regulatory framework governing the medical and nursing professions and the relevant legal provisions, especially highlighting the dos and don'ts for doctors and medical professionals.

In the second session, senior advocate Dr. Gopinath Shenoy and Adv. Amit Karkhanis chaired the discussion. Dr. Shenoy discussed three well-known judgments from India that played a pivotal role in the development of laws related to medical negligence. Mr. Karkhanis spoke on medico-legal issues in surrogacy and reproductive technologies. While discussing these modern procedures and their associated legal aspects, he particularly elaborated on fundamental rights, including the right to privacy.

The third session of the seminar began with an artistic and dramatic presentation based on a real-life case of medical negligence. The play was titled “*Doctor Hajir Ho*”. The script was written and directed by Dr. Shailendra Jadhav and Dr. Swaroopa Iyer along with their team members who are practicing gynecologists in Thane and Mumbai. Through this play, they conveyed a social message that false complaints should not be made against doctors.

In the fourth session, Dr. Richa Bansod, Chairperson of Thane District Consumer Disputes Redressal Commission, elaborated on the ethical complexities surrounding euthanasia in India. She stated that currently, the law recognizes “passive euthanasia” as a part of the “right to die with dignity” under Article 21 of the Constitution. However, active participation in causing someone’s death remains strictly prohibited. This creates a debate on the balance between autonomy and the right to life, where withdrawal of life-support treatment is permitted in terminal cases, but actively ending life is considered morally and legally wrong in most circumstances. In the same session, Dr. Arun Gaikwad, Chairperson of Pune Additional District Consumer Commission, guided the audience on the definition of a consumer, who qualifies as a consumer, what is meant by a complainant, and the procedure for filing a complaint.

In the subsequent session, research papers presented during the seminar were reviewed. Dr. Mahesh Barve, senior anesthesiologist, and Dr. Mrs. Mrunmayee Chavan shared their comments on these research papers.

In the valedictory session of the seminar, Dr. Srividhya Jayakumar, in her concluding speech, highlighted the importance of participating in such seminars and their relevance to professional life, addressing the students. The seminar concluded with a vote of thanks delivered by Professor Vinod Wagh.

## Lecture on Banking by Adv. Anant Gadre at T.M.C. Law College

A lecture by Adv. Anant Gadre on the *Banking Regulation Act, 1949* was organized on 26th February 2025 at T.M.C. Law College. The lecture was conducted in an online mode. In his lecture, Adv. Gadre explained that the main objective of the Act is to regulate banking companies in India and to ensure their stability and sound functioning. He elaborated that the Reserve Bank of India (RBI) grants licenses to banking companies and regulates how they maintain minimum paid-up capital and reserves.

He also discussed the RBI's role in regulating operations such as granting loans, borrowing, and accepting deposits. Furthermore, he explained provisions related to proper accounting and annual auditing which banking companies are required to follow. He highlighted the provisions concerning inspection and supervision, stating that the RBI actively monitors and supervises banking companies.

The lecture was attended by many students. Several students raised queries, to which Adv. Gadre provided in-depth responses.

**Day 1: 9th May 2025**

## Session 1: Inauguration Ceremony

The FDP was inaugurated by Hon'ble Justice Shri Anil R. Joshi, retired judge from the Bombay High Court. His keynote address focused on the dynamic role of legal educators in a rapidly evolving legal ecosystem. Justice Joshi emphasized the importance of aligning teaching practices with constitutional principles, encouraging faculty to engage critically with both law and society. He reflected on how legal education can shape responsible citizens and professionals. The inaugural session set a motivational tone for the week-long event, stressing the values of justice, fairness, and public service. Participants gained insight into the judiciary's expectations from academia. The session also reiterated the role of educators as nation builders. Faculty members felt encouraged and energized to pursue excellence. The ceremony also included introductory remarks by the coordinator and assistant coordinator. The vote of thanks concluded the session, acknowledging all stakeholders involved.

## Session 2: NAAC Binary System – Dr. Kamlesh Kurankar

Dr. Kurankar provided an in-depth overview of the new NAAC Binary Accreditation System. He explained the parameters used to evaluate academic institutions, emphasizing the need for transparency, data-driven reporting, and continuous quality improvement. The session covered aspects such as curriculum design, learning outcomes, faculty performance, student satisfaction surveys, and institutional best practices. Faculty were guided on preparing Institutional Development Plans (IDP) and using ICT tools for documentation. The importance of aligning teaching practices with accreditation criteria was emphasized. Dr. Kurankar also provided examples of successful NAAC reports and shared tools for effective data management. The session was interactive, with faculty raising queries about SSR preparation and peer team expectations. Overall, it offered a practical roadmap to strengthening institutional quality and readiness for NAAC assessment.

## Session 3: Examination Reforms – Dr. Srividhya Jayakumar

In this session, Dr. Jayakumar addressed how examination patterns have evolved post-pandemic and in the digital era. She focused on balancing formative and summative assessments and the importance of evaluation as a learning tool rather than just a grading mechanism. The session highlighted the increasing use of MCQs, case-based assessments, and open-book exams. Dr. Jayakumar urged faculty to shift toward competency-based evaluation that promotes analytical thinking. She emphasized ethical practices in assessment and the significance of timely result processing. The role of digital platforms for conducting online exams and reducing administrative burdens was also discussed. Faculty explored strategies for question paper setting, moderation, and double valuation. This session enabled a meaningful exchange on the challenges and opportunities in modern examination systems.

Day 2: 10th May 2025

## Session 4: Teaching Methodology in Law – Dr. Ravi Mor

Dr. Mor presented a compelling case for transforming traditional legal teaching into a more student-centric model. He advocated for the integration of clinical legal education, simulations, and legal aid work into the curriculum. Emphasizing the move away from rote learning, he encouraged the use of problem-based learning and flipped classrooms. The speaker outlined how the Socratic method, moot courts, and peer reviews could foster critical thinking. He also highlighted the need to adopt e-learning platforms and legal databases to enrich classroom content. Dr. Mor stressed on aligning pedagogy with Bar Council guidelines and legal market demands. He inspired faculty to act as mentors and facilitators rather than mere knowledge providers. The discussion included the psychological aspects of student engagement and inclusive teaching strategies. The session concluded with actionable ideas to rejuvenate law pedagogy in Indian classrooms.

## **Session 5: Faculty Presentations – IPC/BNS**

In this session, faculty presented their comparative studies on the Indian Penal Code (IPC) and the newly enacted Bharatiya Nyaya Sanhita (BNS). Presentations focused on substantial changes in terminology, definitions, and sentencing provisions. Participants analyzed the implications of the changes on procedural law, criminal jurisprudence, and legal education. The discussion highlighted the need for curriculum updates and integrating BNS content in law syllabi. Faculty appreciated the diversity of perspectives shared during the session. This exercise helped improve presentation, research, and articulation skills. The session also stimulated dialogue about the socio-political motivations behind the legal reforms. Questions were raised on the transitional challenges between IPC and BNS, especially concerning ongoing cases. Overall, this session offered a platform for collaborative learning and policy analysis.

## **Session 6: Educational Visits and Internships – Moderated by Dr. Mithun Bansode**

Dr. Bansode led an interactive discussion on organizing effective educational visits and internships for law students. He emphasized that experiential learning is crucial to bridge the gap between theory and practice. Faculty members shared their past experiences in organizing court visits, jail visits, NGO partnerships, and corporate internships. Guidelines for ensuring safety, legal compliance, and educational relevance were discussed. The session also covered how to draft MoUs with host institutions and structure internship reports. Dr. Bansode stressed the importance of feedback from students and hosts to improve the program. He encouraged faculty to involve students in planning such activities to build ownership and responsibility. The discussion was valuable in establishing a practical framework for experiential learning. Faculty agreed to collaborate in creating a centralized database of internship partners.

## **Day 3: 11th May 2025 (Sunday)**

## **Session 7: Management Principles for Law College Faculty – Dr. Krishna Shetty**

Dr. Krishna Shetty provided a refreshing perspective on applying management principles in academic environments. He emphasized that faculty members play multiple roles—as educators, mentors, administrators, and change-makers—and thus must adopt effective time management and communication strategies. The session explored topics such as organizational behavior, leadership styles, team dynamics, and institutional planning. Dr. Shetty discussed how management concepts like delegation, decision-making, and conflict resolution apply to academic settings. He encouraged faculty to focus on institutional vision and mission, while fostering collaboration across departments. Emphasis was placed on emotional intelligence and work-life balance, especially for faculty managing teaching and administrative duties. The importance of feedback loops and self-appraisal systems was also covered. Faculty appreciated the interdisciplinary lens applied to their roles, making the session both practical and motivational.

## **Session 8: Faculty Presentations on IPC/BNS**

Continuing from earlier sessions, faculty presented deeper case studies and interpretations under the new criminal code, BNS. Presenters focused on how certain sections have been revised, omitted, or simplified,

and what this means for legal practitioners and students alike. The discourse brought attention to the shift in the philosophy of punishment, with new provisions reflecting restorative justice elements. Faculty critiqued the clarity and potential ambiguities in certain sections and compared these with global legal frameworks. Suggestions were made to prepare casebooks and updated lecture modules. Presentations also included hypothetical scenarios and their probable legal interpretations under BNS. The collaborative nature of the session enabled a shared understanding of recent legislative developments. It also showcased faculty members' research aptitude and public speaking skills.

Day 4: 12th May 2025

## Session 9: Legal Consultancy in Education – Dr. Anil Variath


Dr. Anil Variath's session bridged academia and professional legal practice by showcasing how consultancy can be a core academic activity. He explained how legal consultancy provides law faculty and students an opportunity to engage with real-life legal problems, thereby making education more applied. Dr. Variath presented models where faculty collaborate with industries, public institutions, and legal aid clinics to offer consultancy services. He also elaborated on the ethical obligations, documentation, and revenue-sharing models involved in consultancy. The regulatory framework and institutional approval required for such endeavors were explained. Faculty were encouraged to build expertise in niche legal areas like environmental law, IP rights, and contract negotiation. The speaker shared success stories from institutions that have formalized consultancy into their academic culture. The session motivated faculty to go beyond traditional teaching and explore interdisciplinary outreach.

## Session 10: Indian Knowledge Systems (IKS) and Jurisprudence – Dr. Prashant Dharmadikari

Dr. Dharmadikari's session offered a scholarly dive into the Indian Knowledge Systems (IKS) and their relevance to jurisprudence today. He highlighted ancient texts like Manusmriti, Arthashastra, and Dharmaśāstra, discussing their influence on modern legal thought. The speaker encouraged faculty to explore indigenous epistemologies and integrate them into comparative law and legal philosophy courses. He presented IKS as a holistic system that blends ethics, law, and societal order. Faculty appreciated the balanced critique of Western legal constructs vis-à-vis traditional Indian jurisprudence. Dr. Dharmadikari also underlined the relevance of Nyaya and Mimamsa schools of logic to legal reasoning. The session concluded with a discussion on how IKS could be introduced into law curriculum innovatively, without compromising secular and constitutional values. It inspired a new cultural lens for looking at law.

Day 5: 13th May 2025

## Session 11: Effective Teaching-Learning Methods – Dr. D. K. Nayak


Dr. Nayak's session which was conducted offline in conference room focused on evolving pedagogical frameworks that cater to 21st-century learners. He explained that legal education must move toward constructivist models, where students build their understanding through reflection and interaction. Topics discussed included flipped learning, blended learning, peer instruction. Dr. Nayak demonstrated how law faculties can design interactive content, quizzes, and feedback systems using low-cost or free digital tools. He also emphasized inclusive education by suggesting strategies for teaching students with varied learning needs. Examples of formative assessment models and continuous evaluation were shared. Faculty discussed barriers they face in applying new methods, such as large class sizes and lack of infrastructure. Dr. Nayak's insights prompted faculty to think creatively about lesson planning and student engagement.

## Session 12: Competition Law – Mr. Nitin Upadhye

Mr. Upadhye, a seasoned corporate lawyer, provided practical exposure to Competition Law, a subject that has become increasingly significant in corporate and commercial legal studies. He explained key concepts like anti-competitive agreements, abuse of dominance, and merger control through real-world case studies, including landmark decisions by the Competition Commission of India (CCI). The session bridged theory and practice, helping faculty understand how to frame questions and hypotheticals around competition issues. Mr. Upadhye also addressed the interface between competition law and digital markets, particularly the role of Big Tech. He encouraged faculty to follow global developments and recent CCI reports as teaching resources. Regulatory challenges, compliance issues, and litigation trends were discussed in depth. The session highlighted the importance of keeping legal education contemporary and market-aligned.

Day 6: 14th May 2025

## Session 13: Role of Teachers in Inculcating Constitutional Values – Dr. Varsha Deshpande

Dr. Varsha Deshpande emphasized the pivotal role that educators play in shaping the moral and civic consciousness of students. She spoke about the values enshrined in the Preamble of the Indian Constitution—justice, liberty, equality, and fraternity—and how teachers can actively instill these ideals through both curriculum and classroom behavior. Dr. Deshpande advocated for integrating constitutional discussions in all subjects, not just Constitutional Law, to ensure that students understand their rights and responsibilities as citizens. She provided practical examples of classroom activities and community projects that promote democratic participation and respect for diversity. The discussion touched on critical issues such as gender justice, social equity, secularism, and environmental responsibility. She urged faculty to act as role models and mentors who embody constitutional ethics in their conduct. The session concluded with an open forum where faculty reflected on how they currently address these values in their teaching and how they can strengthen this aspect further.

## Session 14: Research & Publication – Dr. Shraddha Bhome

Dr. Shraddha Bhome led an insightful offline session on how faculty can effectively manage their time and resources to engage in meaningful research and academic publishing. She discussed the stages of research—from identifying a topic, conducting literature reviews, formulating hypotheses, and selecting methodology, to writing and submitting papers. She warned against predatory journals and emphasized the importance of publishing in peer-reviewed and indexed journals. Dr. Bhome shared time-management techniques specifically tailored for teaching faculty with heavy academic loads, encouraging the use of research logs, collaboration with colleagues, and goal setting. She also introduced tools like Mendeley, Google Scholar, and UGC CARE lists for organizing and identifying credible sources. Faculty were encouraged to engage in interdisciplinary research and apply for minor/major research grants. The session was particularly motivating for young faculty who felt inspired to initiate their research journeys with confidence.



## Session 15: Faculty Presentations and Tests

Each participant demonstrated their learnings and reflections through detailed PowerPoint presentations or oral expositions. Topics ranged from innovative classroom practices, comparative law modules, the implications of new legal codes, and constitutional ethics in education. The session provided a platform for peer learning and critical feedback. Presentations were assessed based on clarity, content depth, originality, and engagement. Faculty also appeared for a test designed to evaluate their grasp of key FDP themes, such as NAAC guidelines, research ethics, and teaching tools. This session fostered healthy academic competition and highlighted the professional growth of faculty throughout the FDP. The confidence and quality of presentations were notable, reflecting the FDP's impact.

## **Session 16: Final Presentations and Assessment Continuation**

Like Day 7, participants focused on new teaching strategies, curriculum redesign proposals, or research outlines aligned with institutional and NAAC goals. The interactive session promoted self-assessment and encouraged faculty to document their presentations for future reference and use in API scores. Some presentations also showcased strategies for incorporating legal clinics and public legal education as co-curricular tools. Faculty appreciated the opportunity to share their innovations and receive constructive suggestions from peers and mentors. This collective exchange contributed to a strong sense of community and collaboration among the teaching staff.

## **Valedictory Ceremony – Hon’ble Justice Abraham Mathew**

The FDP concluded with a valedictory address by Hon’ble Justice Abraham Mathew, retired judge of the Kerala High Court. Justice Mathew delivered an inspiring speech on the higher purpose of education in nurturing just societies and fostering leadership based on ethics and responsibility. He praised the role of law teachers in preserving democratic institutions by empowering the next generation of legal professionals. Justice Mathew encouraged continuous self-improvement, reading, and critical engagement with current affairs. His words reinforced the FDP’s core message: that educators are not just transmitters of knowledge, but torchbearers of constitutional vision. The vote of thanks acknowledged the efforts of all faculty members, coordinators, resource persons, and supporting staff who made the FDP a success.

## **Final Reflections and Acknowledgments**

This 8-day FDP not only broadened the intellectual and professional horizons of the faculty but also created a vibrant academic environment driven by collaboration, critical thinking, and innovation. 

*Organized as part of Patriotism Week Celebrations*


*Hosted on Google Meet at 8:00 PM*

## Observations and Feedback of the Team:



**"Disaster mitigation... enhances the self-reliance of vulnerable people – in other words, it empowers them."**

With this very sentiment, a special practical training session on disaster management was organized on 9th April 2025 at VPM's Law College, Thane, as a part of the additional certificate program under Disaster Management Law. It was our privilege to host two exceptional Master Trainers from Yashwantrao Chavan Academy of Development Administration (YASHADA), Pune — Mr. Vivek Naidu and Mr. Lakhan Gaikwad.

The session began at 3:00 PM in the college's Manu Auditorium (Moot Court Hall). Assistant Professor Mrs. Krishna Kamath Keskar welcomed all attendees and introduced the master trainers. Mr. Vivek Naidu kickstarted the session with engaging brain teaser activities to capture students' attention and emphasized the critical importance of disaster management training. He explained that whether natural or man-made, disasters can strike anytime, anywhere, and we must be equipped with basic training to save ourselves and others using limited available resources. - Basic life support (CPR)
- Fire safety techniques, including handling of fire extinguishers
- Response strategies for situations like snake bites, dog bites, and bee attacks

Through real-life examples of disasters, the importance of small preventive actions like turning off the gas regulator before sleeping was also highlighted.

At the end of the session, students were taken to the college basketball court, where they received hands-on training in opening and using fire extinguishers with extreme caution and safety. This was particularly useful since, despite fire extinguishers being available on campus, many students are unaware of how to operate them effectively.





## Convocation Ceremony of the 50th Batch of Vidya Prasarak Mandal's TMC Law College Celebrated

On 17th May 2025, the Convocation ceremony of the 50th batch of the reputed Vidya Prasarak Mandal's TMC Law College was held at the hands of Hon'ble Justice Shri Abhay Oka of the Supreme Court of India. On this occasion, Chief District Judge of Thane District Court Shri S. B. Agrawal, Secretary of District Legal Services Authority Shri Ishwar Suryawanshi, Former Presidents of the Bar Council of Maharashtra and Goa Shri Gajanan Chavan and Shri Sudeep Pasbola, President of Vidya Prasarak Mandal Dr. Vijay Bedekar, and Secretary Shri Abhay Marathe were present on the dais.

On this occasion, the In charge Principal of the College, Dr. Srividhya Jayakumar welcomed all dignitaries and presented the introduction of the ceremony. While guiding the students, Chief District Judge of Thane, Shri Agrawal said that the legal profession can be pursued only with great effort and regular study. He advised the students to continue their legal studies regularly under all circumstances and keep reading new judgments. He extended his best wishes to the students entering the legal profession.

Former Presidents of the Bar Council of Maharashtra and Goa, Shri Gajanan Chavan and Shri Sudeep Pasbola, assured the students that if they face any kind of difficulty, the Bar Council would help them.

In his address, the President of the institution, Dr. Vijay Bedekar, expressed his expectation that all books, information, and judgments related to law should be available in the Marathi language for the common citizens. He urged students to come forward to translate legal material into Marathi and make it accessible to the general public.

The Chief Guest of the function, Hon'ble Justice Shri Abhay Oka of the Supreme Court, while guiding the students, stated that the legal profession has become one of the most sought-after professions globally and has opened up a variety of opportunities. In earlier times, after obtaining a law degree, advocacy was the only available option, but now students have multiple opportunities before them, such as advocacy, becoming a judge in the judiciary like Judicial Magistrate First Class, District Judge, working as legal officers in companies, practicing in special courts, becoming public prosecutors, and also taking up teaching roles in law colleges.

Justice Oka further stated that in the past three years, the Supreme Court has taken the initiative to translate its English judgments into major Indian languages, and thousands of judgments have already been translated into various Indian languages. He also mentioned that for the past 30 years in Maharashtra, work is conducted in Marathi up to the District Court level. Sharing many of his own experiences, he explained the skills required to succeed in the legal profession. He stated that with the tools available today, studying law, conducting legal research, understanding legal concepts, and analyzing several judgments in less time has become much easier. He wished all the students success in their legal careers through proper utilization of these tools and rigorous legal study.

During the ceremony, degrees were conferred upon 150 students of the Law College. Special appreciation was given by Hon'ble Justice Oka to four differently-abled students.
