

Following the lecture, the students engaged in an open dialogue with Mrs. Pal. The event was anchored by Adv. Raj Nalghe and alumna Kshitija Khangte.



## "International Democracy Day" Celebration on September 15

Every year on September 15, International Democracy Day is celebrated worldwide, serving as a reminder and celebration of governance focused solely on public welfare. According to the Universal Declaration of Human Rights of 2008, recognizing and celebrating democracy is not merely a need; it is a right of every individual. To commemorate this day, numerous parliamentary events, photography competitions, debates, and other activities are organized globally. Similarly, VPM's TMC Law College, Thane, in collaboration with the Electoral Literacy Club, organized a workshop at 4:30 PM on September 15, 2023, to celebrate this occasion. The workshop was divided into three distinct stages, the first of which was an oratory competition on the topic "One Nation, One Election." In this competition, students expressed their views on how the structure of Indian elections aims to unify the electoral system. They discussed how the election cycle should ideally be set so that elections for the Lok Sabha and state assemblies could be synchronized within a fixed period. On this occasion, participants also conducted a deep comparative analysis of the voting systems of India and the United States.

The second stage of the event featured Mr. Edric Miranda, a legal journalist and legal expert with experience practicing in India and other countries. Mr. Miranda, who specializes in intellectual property rights, arbitration, Chinese law, Portuguese law, and other topics, gave a lecture. His primary topic was "Legal Remedies through Legislation," which uniquely addressed how justice can be sought through law rather than solely through courts. students with the message that despite of manier hurdles women's are proving their excellence but still need to do many more things.


Lastly, Prof. Ms. Hetal Meishari and Prof. Mrs. Samata Joshi announced the result of competition on the same day.



## LLM And Additional Division

### Application Regarding Additional Division of LL.M. and LL.B. by the College:

As per the summons of the Honorable Vice-Chancellor regarding the grievance hearing on the application submitted by the college to the university for the additional division of LL.M. and LL.B., the In charge Principal of the college, Dr. Srividhya Jayakumar, along with the representative of the Management Committee, Mr. Ravindra Rasal, were present at the university's Fort campus office on 18th March 2024. Prior to this, on 15th March, the In charge Principal had submitted a written reply to the university's letter, mentioning that the proposal was rejected due to the following reasons: lack of NAAC accreditation, non-availability of approved faculty, and absence of a regular principal. In response, the college drew the university's attention to the fact that in December 2023, the college had secured NAAC accreditation (Second Cycle). Additionally, the college informed the university that an advertisement had been published on 19th February for the recruitment of six faculty positions.

## Disaster Management Practical Training:

"Disasters are beyond our control, but we can control how prepared we are."

In line with this sentiment, a special Disaster Management Practical Training was organized on April 15, 2024, as part of an additional certificate program at VPM TMC Law College, Thane. The training covered Disaster Management Law and was conducted by exceptional trainers from Yashwantrao Chavan Academy of Development (YASHADA), Pune, including Shri Vivek Naidu, Shri Lakan Gaikwad, and Shri Akshay Patil.

The session began at 2:30 PM in the college's Manu Hall (Moot Court Hall). The program started with a warm welcome by Assistant Professor Mrs. Krishna Kamath Keskar, followed by the introduction of the trainers and their felicitation. The In-Charge Principal Dr. Shri Vidya Jayakumar delivered the welcome speech.

Shri Vivek Naidu initiated the training session, engaging students with brain teaser activities to capture their full attention. He emphasized the significance of disaster management training in our daily lives, explaining that natural or man-made disasters can occur at anytime, anywhere. He stressed that we must be equipped with basic life-saving skills and limited available resources to save ourselves and others.

As the training progressed, various practical aspects were covered, including life-saving techniques, basic first aid training (CPR), firefighting, and other essential skills. Dr. Mahesh Barve, a senior anesthesiologist and visiting faculty member, demonstrated CPR techniques. The master trainers also shared life-saving measures for incidents such as snake bites, dog bites, and bee stings. They also highlighted real-life emergency situations, such as the need to turn off gas regulators before going to bed.

At the end of the training, students were taken to the college's basketball court, where they were given hands-on training on how to use a fire extinguisher and extinguish a fire. This was an important lesson, as even though fire extinguishers are available in many places, people rarely know how to use them effectively. The training ensured that students learned how to operate firefighting equipment and apply it in real-life situations.

## NAAC RE-ACCREDITATION

**TMC Law College of Vidya Prasarak Mandal received accreditation from NAAC in 2004.** Among all the law colleges under Mumbai University, the college of the Mandal was the only college to have NAAC accreditation. Until around 2020, the institution's college remained the only NAAC-accredited law college within Mumbai University. With the aim of securing NAAC accreditation once again, the college initiated the NAAC accreditation process in the academic year 2021-22. For this, the necessary cooperation and guidance were provided by the administrators of Vidya Prasarak Mandal, particularly the invaluable support and guidance of the institution's working president, Dr. Vijay Bedekar, and Dr. Mahesh Bedekar.

Overcoming all challenges within the college, the complete report for 2021-22 was submitted to NAAC after fulfilling all necessary processes and paying the required fees. The NAAC members were invited for inspection. As per NAAC rules, the AQAR was completed, and the IIQA and SSR were filed. Considering all the reports submitted by the college, NAAC decided to visit the college on December 14 and 15, 2023. The college completed all the pre-inspection processes on time as per NAAC rules. Accepting all challenges and following the Mandal's guidance, the college prepared for the NAAC visit by forming various committees and ensuring proper preparation.

On December 13, 2023, the faculty and students welcomed the NAAC members at Mumbai Airport. As per NAAC rules, a zero meeting was held at 10 PM on December 13, 2023, in which the institution's president Dr. Vijay Bedekar, In Charge Principal Dr. Srividhya Jayakumar, and IQAC Coordinator Prof. Vinod Wagh were present. 


